Chancellor Dr. Harsin introduced students and faculty attending the meeting. Faculty Kami True (Nursing), Stephanie Knox (Nursing), George Tackett (INDT), Ron Novak (INDT), Nursing students Cheyenne Webster and Emily Ayler, and Welding students Tanner Jacobs and Collin Tolliver.

Resolutions

Chancellor Dr. Harsin reviewed Resolution 2023-05 Nursing Expansion Project (Phase 2), Resolution 2024-01 New Academic Program for AY 2024-25 (Building and Property Maintenance Technician Certificate), and Resolution 2024-02 New Academic Program for AY 2024-25 (CNC Machinist Technician Certificate). Trustee Clayton moved to approve the motion, Secretary Lewis seconded the motion, and the motion carried unanimously. (Chairperson Dozier reclused herself from the 2023-05 Nursing Expansion Project (Phase 2)).

Chancellor's Report

Chancellor Dr. Harsin gave the floor to Vice Chancellor Dr. James to discuss the Service-Learning program. Vice Chancellor James then introduced the students and turned the floor over to them to elaborate on their service-learning projects. Students Tanner Jacobs and Collin Tolliver presented to the Board their experience participating in Hanover's Tinsel Twinkle Trail. Nursing students Cheyenne Webster and Emily Ayler shared with Board members their service-learning project for Mental Health in the Community. Students prepared care kits for unhoused members of the community, supplied handouts on self-hygiene and infection prevention, made donations to the Salvation Army, and volunteered at Madison Goodwill.

Chancellor Dr. Harsin and Vice Chancellor Dr. James thanked the faculty and students for attending and sharing. Chairperson Dozier turned the floor over to Vice Chancellor Stewart.

Enrollment Report:

Dustin Stewart, Vice Chancellor of Enrollment and Student Success, presented the Enrollment Reports as follows:

Fall 2023 Enrollment Data: 1,128 enrolled for Fall, up 148 from Fall 2022.

Spring 2024 Enrollment Data: 1,022 currently enrolled

Fall 2023 to Spring 2024 Retention: Currently at 75.76%

Chairperson Dozier turned the floor over to Chancellor Dr. Amanda Harsin for a Correctional Education update.

Chancellor Dr. Harsin shared Performance Metrics with the Board. The annual goal is 3100 students enrolled in Adult Basic Education. Currently, 1,837 are enrolled (59% of goal). Dr. Harsin updated members on the quality site reviews that are currently taking place.

APPROVAL OF MADISON CAMPUS – NEW ACADEMIC PROGRAM FOR AY 2025-26 RESOLUTION 2024-03

WHEREAS, development of the criteria and guidelines for the Ivy Tech Veterinary Nursing AAS has been completed by the School of Advanced Manufacturing, Engineering, and Applied Science members (e.g., Curriculum Committee, Program Chairs, Deans, Curriculum AVP / VP, and VCAAs), and

WHEREAS, this degree

- is dedicated to developing knowledgeable, skilled, and compassionate animal care professionals. This degree program prepares skilled and work-ready veterinary technicians for licensure to enhance animal and human well-being through theoretical and practical learning experiences in advanced and innovative learning environments. Licensure demonstrates their readiness to successfully lead and innovate in veterinary medicine.
- is a 27-course, 77.5 credit AAS Degree program. Included in the 27 courses are: 17 core / technical courses, 4 externship courses, and 6 general education requirement courses.
- can be completed in two years. Earning the Veterinary Nursing AAS Degree
 meets the qualifications to register for and take the Veterinary Technician
 National Exam (VTNE) to become certified, registered, or licensed depending
 on the state's terminology (The state of Indiana recognizes the Registered Vet
 Tech, RVT, distinction). Students are encouraged to take the VTNE to become
 certified, registered, or licensed depending on the state's terminology (The
 state of Indiana recognizes the Registered Vet Tech, RVT, distinction).
- includes the embedded Veterinary Assistant Certificate requirements in year 1.
 Students will be awarded a certificate of completion after successful completion of the requirements in year 1 of the program. Earning the Veterinary Assistant Certificate meets the qualifications to register for and take the Approved Veterinary Assistant (AVA) certification examination. Students are encouraged to take the AVA certification examination.
- is expected to align with a current estimated 122,900 Veterinary Nurses / Technologists in the US with 2,530 of them in Indiana. The annual mean wage for this profession in Indiana is \$38,850. About 14,800 openings for veterinary technologists and technicians are projected each year, on average, over the decade. Many of those openings are expected to result from the need to replace workers who transfer to different occupations or exit the labor force, such as to retire. There is an expected 21% job growth projection over the next 10 years in the Veterinary Nursing field which is much faster than average.
- will be offered at Ivy Tech Madison Campus and at the Veterinary Teaching Center on the campus of Hanover College. The Veterinary Teaching Center is made possible because of the READI Grant funded partnership with Ivy Tech Madison and Hanover College.

NOW THEREFORE BE IT RESOLVED, that the Madison Campus Board of Trustees do hereby approve the Veterinary Nursing AAS for implementation in the 2025-26 academic year.

WHEREAS, this certificate

- is dedicated to generating and promoting a foundation of excellence in aspiring animal care professionals. This certificate program prepares skilled and workready veterinary assistants for approval to enhance animal and human well-being through theoretical and practical learning experiences in advanced and innovative learning environments. Approval demonstrates their readiness to successfully perform and grow in veterinary medicine.
- is a 9-course, 28-credit Certificate program. Included in the 9 courses are: 7 core / technical courses and 2 externship courses.
- can be completed in one year and will be awarded a certificate of completion
 after successful completion of the requirements. Earning the Veterinary Assistant
 Certificate meets the qualifications to register for and take the Approved
 Veterinary Assistant (AVA) certification examination. Students are encouraged to
 take the AVA certification examination.
- is embedded in year 1 of the Veterinary Nursing AAS Degree program. Students will be awarded a certificate of completion after successful completion of the requirements in year 1 of the program. Earning the Veterinary Assistant Certificate meets the qualifications to register for and take the Approved Veterinary Assistant (AVA) certification examination. Students are encouraged to take the AVA certification examination.
- is expected to align with a 19% job increase through 2026, which is considered much faster than average positions. There are currently 3,098 Veterinary Assistants employed in Indiana with an average salary of currently just over \$26,000 per year.
- will be offered at Ivy Tech Madison Campus and at the Veterinary Teaching Center on the campus of Hanover College. The Veterinary Teaching Center is made possible because of the READI Grant funded partnership with Ivy Tech Madison and Hanover College.

NOW THEREFORE BE IT RESOLVED, that the Madison Campus Board of Trustees do hereby approve the Veterinary Assistant CT for implementation in the 2025-26 academic year.

This group of people work together to promote and ensure academic success among the students in more than 36 degree programs, several and varied certificate programs, across seven schools.

Fall 2023 and Spring 2024 Semester Student, Faculty, and Staff Highlights

LIBRARY SERVICES

Madison Library Services is headed by Mr. Tim Renners – Library Director/DSS Coordinator.

Library Usage Statistics:

Gate Count: We are delighted to report that the library gate count for the Fall 2023 semester was approximately 2286, indicating a consistent and healthy level of foot traffic through our doors. This demonstrates the continued importance of the library as a hub for academic pursuits and research on our campus.

Library Assistance Count: Throughout the semester, our dedicated staff assisted approximately 239 library users, ensuring that students, faculty, and staff had access to the resources and support they needed to succeed in their academic endeavors.

Library Instruction: A total of 39 students benefited from library instruction sessions during the Fall 2023 semester. These sessions play a crucial role in equipping students with the necessary research skills and information literacy to excel in their studies.

Library Community Users: We were pleased to welcome 44 community members to our library during the Fall 2023 semester. By opening our doors to the broader community, we foster a culture of lifelong learning and collaboration beyond the confines of our institution.

DSS Accommodations: In line with our commitment to accessibility and inclusivity, we provided accommodations to 25 students with disabilities through our Disability Support Services (DSS) program. Ensuring equal access to library resources and facilities remains a top priority for us.



Veterinary Nursing & DVM Update


We are pleased announced that the Veterinary Nursing AAS and Veterinary Assistant CT new program proposals have been passed by the Ivy Tech's Chief Academic Officer Committee as of March 2024. The new program proposals are finishing internal review and approvals before being submitted to external accreditation / authorization agencies (HLC, ICHE, CVTEA of the AVMA, and NAVTA) for a Fall 2025 program launch. Hanover College is moving through similar processes for the accreditation / authorization of the DVM for a Fall 2026 program launch. Construction plans are moving forward for shared Ivy Tech and Hanover Veterinary Teaching Center on Hanover's campus.










Trend Data for Spring 2024

MVP Launch

Students will have the opportunity to receive academic support from lvy Tech, tuition assistance from employer partners, and access to internships, work experiences, and potential full-time employment opportunities upon degree completion. Ivy Tech Correctional Education

March 2024

Current IDOC Contract status: Year 3 Quarter 3

During the past quarter, correctional education has been actively engaged in addressing the GED testing backlog due to the inability to test during the transition from HiSET to GED. The state team, in collaboration with each site have meticulously reviewed existing data to strategize on establishing robust pipelines conducive to achieving our completion metrics.

Initiatives have been developed to bolster enrollment figures, optimize the utilization of student tablets, and broaden the scope of current tutoring programs. Furthermore, sites are being trained to implement professional learning communities in efforts to enhance student success rates, complemented by the recent launch of a teacher mentoring program.

Notable, the State Team and Dr. Harson have attended comprehensive mid-year reviews across all 15 facilities. These sessions entailed discussions on current data trends, successful methodologies, and updates on site goals and objectives.

Looking ahead, the next quarter will have the Correctional Education Spring Conference, where *Outward Performance* through the Arbinger Institute will be extended to all correctional education staff; sites and the state team will develop SWOT analyses and Needs Assessments; all sites will be trained in Professional Learning Communities, and efforts will intensity to achieve our enrollment and completion targets.

Current Accomplishments:

- Correctional Education has maintained around 80% capacity in both ABE and Vocations.
- State Team and Dr. Harsin have visited all 15 sites for Mid-Year Reviews
- 8/15 Sites have been trained in Professional Learning Communities
- Correctional Education has been above the state average on Table 4 and has met the distance learning goal.

Project Updates:

Professional Learning Communities: Rob Moore, Consultant from DWD, has provided training in PLCs in 8 sites with all sites scheduled to complete training by 4/29/24. For PLC information visit: https://www.youtube.com/watch?v=iUUVahqklj4

Outward Performance Implementation: Arbinger facilitators have been meeting weekly to practice facilitating sessions for the Spring Conference in April. The State Director has been meeting monthly with an Aribinger consultant to determine how to measure the success of tis initiative utilizing the current Gallup Survey for Employee Engagement. New teacher mentoring: New teachers have been provided a mentor with veteran teaching staff. This will assist new teachers with best practices, training materials, resources, and networking opportunities.

Study Buddies: Correctional Education is currently working on funding opportunities to purchase study buddies for teachers who have expressed desire to use them in the classroom.

IET Design Camp: Putnamville Correctional Facility will run a pilot program that removes the HSE requirement for admittance into the current IET Logistics program. The goal is for the student to obtain their HSE and CLA/CLT certification simultaneously. This class will start in April.

Tutor Expansion Project: IT CE Tutor Expansion Committee has developed a training manual for tutors. It will be delivered to staff within the next few weeks.

Out-Custody:

- 105 Enrollments over 6 facilities (34.53% of goal)
- 84 Completions (1 class in progress) 27% of goal
- Factors impacting classes:
 - IDOC Staffing shortage of guards at facilities impacts when classes can run, and limits our instructor availability
 - Reduced eligible inmate population


